3. Te Whatu Ora

3.1 Vaccination Insights

As of 26 September, 2,697,006 people had received their first booster, which is 73% of the eligible population. For age groups 18 and over, at least 50% of those eligible received their first booster dose, which includes 50% of 18 to 24-year-olds, and 75% of 45 to 49-year-olds. A total of 570,743 second booster doses have been administered.

Approximately 31.1% of all eligible Māori and Pacific people aged 50 years and older have received a second booster, an increase from 30.5% the previous week. Roughly 55.7% of non-Māori non-Pacific aged 65 years and older have received a second booster, an increase from 55.1% the previous week.

Outreach Campaigns

For the week 19 to 22 September 2022, 31 national phone campaigns were undertaken to support population uptake on boosters, with a focus on those aged 50 and over and on prioritising eligible Māori and Pacific populations.

In total, 19,489 eligible people were called with 22% (4,297) answering these calls. Of those who answered, 1.41% (61) went on to book an appointment, while 33.8% (1,370) advised they did not require assistance as they will attend a walk-in or manage this through their primary health provider.

Novavax

The Nuvaxovid stock recently delivered to New Zealand has not met Medsafe release requirements. Novavax has supplied Medsafe with additional information to support the release of this stock, with a response expected by 30 September 2022. Alternative batches may be available from Australia to ensure continuous supply, should the stock in New Zealand not meet release requirements. The in-use stock will expire on 31 October.

Communications and Engagement

The nationwide campaign encouraging New Zealanders to be up to date with their COVID-19 vaccinations, including boosters, ended on Friday 30 September. A range of targeted initiatives continue, including a partnered advertising campaign with Karawhiua due to get underway on 3 October to promote booster uptake in Māori communities.

Ngāti Porou's Tomo Mai vaccination campaign funded by the National Immunisation Programme (NIP) has led to the creation of a wellness brochure, updated web content, radio advertising (English and Te Reo Māori), print advertising, billboards, social media and videos. Tomo Mai also partnered with East Coast rugby across the National Provincial Championship Heartland Men's competition, and the Senior Women's competition, to further promote vaccination. Seven vaccination events were organised to leverage off this promotional activity.

Work is underway with Te Aupōuri, Tūwharetoa and Te Arawa Whānau Ora to provide communications advice and support on bespoke vaccination campaigns within their iwi. While these campaigns will focus on promoting COVID-19 vaccinations, other vaccines such as flu, MMR and childhood immunisations may also be incorporated where appropriate.

Aged Residential Care Facilities

All districts have confirmed first visits for second booster doses to Aged Residential Care (ARC) facilities will be completed by the first week of October. This excludes facilities where all residents have tested positive for COVID-19 within the last three months. Clinics for these facilities are booked for the date the residents become eligible.

Boosters

Health Districts continue to develop innovative approaches to supporting COVID-19 booster uptake. Te Tai Tokerau District have begun focussing mobile outreach teams to General Practice locations which do not have available appointment capacity. The mobile service is set up in the GP carpark and provides MMR, childhood and COVID-19 vaccinations to take the pressure off GPs enabling them to focus on clients' other health needs.

3.2 Equity

Māori Update

Māori health providers continue to run hauora events where collective aspects of whānau hauora and wellbeing are the focus, of which vaccination is one part.

On Tuesday 20 September, Te Ngaakau a Kiwa Charitable Trust, a volunteer-led Māori health provider established in 2021 and based in the Waikato region, had met with Minister Henare to discuss their mahi, challenges they are currently facing and opportunities to expand their services further in future. Following this meeting, NIP's regional account manager for the Te Manawa Taki/Midlands region will continue to engage with Te Ngaakau a Kiwa to explore how NIP can support them to continue their mahi.

Pacific Update

Pacific Vaccination Events

Four Pacific vaccination events were held in Tāmaki Makaurau over the weekend of 24 to 25 September. These events included a walk-in pop-up clinic at the Pasefika Vibes Market in Manurewa hosted by Pasefika

Family Health Group and three drive-through events hosted by Southseas Healthcare, The Fono and the Tongan Health Society. A total of 415 COVID-19 and influenza vaccinations were administered.

Pacific Aotearoa Community Outreach Fund

The Ministry for Pacific Peoples has received over 400 applications for the Pacific Aotearoa Community Outreach Fund since it was launched at the start of September 2022. The fund's aim is to support Pacific communities across Aotearoa to respond to the impacts of COVID-19 through developing community-led initiatives. While the high number of applications has led to some delay in their processing, the Ministry for Pacific Peoples is working through a process to fast-track the approval of applications to enable funds to be administered to successful applicants as soon as possible.

Tuvalu Language Week

Pacific health providers will be running vaccination events in alignment with this year's Tuvalu Language week theme throughout the week.

Five Reasons to Get Your Booster Campaign

A range of collateral, including Pacific-focused collateral in Tongan, Samoan and English, has been developed as part of the "Five Reasons to Get Your Booster" campaign. It has been distributed to Pacific health providers and community stakeholders to support increased booster uptake among Pacific communities.

Disability Update

As of 22 September 2022, 89% of disabled people aged 12 years and over who receive Disability Support Services (DSS) funding have completed their primary course of vaccination for COVID-19. Seventy-eight percent of this cohort who are eligible for a booster have received one.

Twenty-nine percent of children aged 5 to 11 years who receive DSS funding are fully vaccinated for COVID-19 and a further 21% are partially vaccinated.

As of 22 September 2022, 86% of people aged 12 years and over who use mental health and Alcohol and Other Drug (AOD) services have completed their primary course of vaccination for COVID-19. Booster uptake among this cohort has increased slightly to 59%.

4. Managed Isolation and Quarantine Weekly Report

4.1 Top Items to Note

4.1.1 Proposed COVID-19 Public Health Response Legislation Cabinet Paper: Proposal to Remove MIQ Powers

Cabinet is due to consider a paper from DPMC on significantly reducing many powers in the COVID-19 Act, replacing them with a narrower set of powers that would continue in either an extended or replacement piece of legislation through until 13 May 2025. This proposal includes removing the remaining ‘dormant’ MIQ powers. The paper outlines MBIE’s concerns at a high-level. For your reference, in MBIE’s view there is little to no legal risk in retaining these MIQ powers in case they are needed quickly in the future, and MBIE does not support removing them. MBIE notes that removing the MIQ powers will:

1. **Delay Readiness activation timelines and increase reliance on self-isolation in the interim.** The Readiness Plan timing for accommodating returnees in three to four weeks after the Plan is activated relies on MIQ powers remaining in place. If these powers are removed and MIQ facilities are required, it will take more time than the three to four weeks currently indicated in the Readiness Plan to set up these facilities.

In this event, New Zealand will need to rely on population compliance with self-isolation for longer or apply heavier border restrictions to manage any public health risk. If Cabinet agrees to remove the MIQ powers from the COVID-19 Act, MBIE will need to revisit the timing in the Readiness Plan.

2. **Allow cost recovery of MIQ fees to continue, but transitional provisions should be included in any new COVID-19 legislation to provide clarity and minimize legal risk.** Processing cost recovery, waivers and complaints is still an active process for MBIE.

The repeal of the ‘cost recovery’ provisions in subpart 3A of Part 2 of the COVID-19 Act will remove existing powers relating to the making of regulations for the recovery of MIQF costs.


However, transitional provisions can be included as part of any new COVID-19 legislation to ensure that the ability to recover existing MIQF debts is maintained. To provide certainty around the ongoing cost recovery processes it is important that these transitional provisions are included.

4.2 Operational Update

The table below shows the number of invoices issued as of 25 September 2022.

Invoices have various repayment terms depending on whether they are a sports group (10 days), critical worker (30 days) or standard returnee/maritime crew/aircrew (90 days).

Please note that for all arrivals from 20 August 2021, all invoicing had payment terms of 30 days except for sports groups under Crown Service Agreements who have 10 days.

4.2.1 Debt Recovery

The debt recovery percentage is now 87 percent, which is against our nominal target recovery of 90 percent.

As of 25 September, 15,190 invoices worth \$45.8m have been passed to our debt partner. In addition:

- \$19.8m has now been paid (an increase of \$275k);
- A further \$322k of debt is under instalment and is expected to be converted to payments over coming weeks; and
- There are 243 active fee waiver requests, while applications are processed, they are recorded as outstanding debt.

4.3 Ombudsman Complaints

As of 28 September, there are seven active investigations:

- one is on policy advice;
- two are on emergency allocations;
- one is on exemptions from managed isolation;
- one is a declined fee waiver application;
- one is about facilities; and
- one is the Chief Ombudsman's self-initiated investigation.

To date, 259 investigations have been closed, with the Chief Ombudsman issuing 123 opinions in MBIE's favour and eight final opinions against MBIE.

There are 104 preliminary enquiries. Preliminary enquiries are cases where the Ombudsman requests the file to assess the complaint and determine next steps.



5. Border Executive Board Report

This update is provided to you as the responsible Minister for the Border Executive Board.

5.1 Border Executive Board Meeting

The Board did not meet this week, with the next meeting scheduled for 5 October 2022.

5.2 Border Executive Board Annual Report

The Border Executive Board 2021/22 Annual Report is due to be presented to Parliament by Friday 21 October 2022. The Report provides an overview of the Border Executive Board, its functions and responsibilities, progress against the work programme, and highlights of the year. The content of the Border Executive Board Annual Report was approved by the Board.

As The New Zealand Customs Service (Customs) are the servicing department for the Border Executive Board, the financial statements and non-financial performance information relating to the Board are reported as part of the New Zealand Customs Service Annual Report.

To align the two documents, the Border Executive Board Annual Report is appended to the Customs Annual Report for the purposes of publication and presenting it to the House. The Border Executive Board Annual Report will be published on the Customs website after it has been presented to the House.
